The Value of Friends Among the Elderly

Dr. Rosemary Blieszner, Alumni Distinguished Professor of Human Development and Associate Dean of the Graduate School at Virginia Tech will be the speaker for the first public meeting of the year on January 21. Dr. Blieszner will speak on the value of friends among the elderly, a topic of research that she has pursued for many years. The meeting will be held at the Blacksburg Community Center on Patrick Henry Drive at 11:30 a.m.



Dr. Blieszner received her Ph.D. from The Pennsylvania State University. Her research has been supported by NIH and several foundations. She has published four books as well as nearly 100 book chapters and

research articles in gerontology, family studies, psychology, sociology, and personal relationships journals. She is a fellow of the American Psychological Association, the Association for Gerontology in Higher Education, the Gerontological Society of America, and the National Council on Family Relations. Legislative Report to the Board of Directors

Blacksburg AARP April 2014

- **1. State Budget**. At a stalemate. Both Governor and House have submitted new revisions but neither party has accepted the proposals. There is a possibility of a Government "shutdown" if a timely decision is not made soon. The full Senate does not reconvene until April 7.
- 2. Medicaid Expansion. Another stalemate. Major ideological differences exist between the Governor/ Senate and the House. Several proposals have been offered as a compromise to the Federal Plan but so far all have been rejected. Whatever is decided here will probably have an impact on a large number of our citizens.
- **3. Delegate Yost and Medicaid Expansion**. This is a very important subject for him and he sent out an extensive survey to those on his mailing list to get input. If you did not receive a copy you can still participate by calling his office (540-922-8032 or 804-698-1012)
- **4. Medicare Patients.** Fees paid to your attending physicians were scheduled to be reduced by double digit amounts in the next few months. However, the U. S. Congress has pending legislation which if approved would reduce this percentage significantly thereby helping to prevent costs being passed on to the individual.
- **5. Health care bills and your credit rating.** Sometimes these bills even though not your responsibility are not paid on a timely basis. These unpaid bills are sometimes reported quickly to credit agencies and could affect your credit score. Currently half of all accounts reported to credit agencies now come from medical bills. And health care bills are now the largest source of business for collection companies. Be as vigilant with these bills as you are with other major bills. Val Coluni, *Chair Legislative Committee*

Area Plan for Aging Services

Looking ahead and planning for activities in the warmer months ahead can help keep us out of the winter doldrums. If we haven't already, we will soon begin to see sure signs of spring.....lovely little crocus blooms, perky robins and shoots of green springing out of the ground!

These assurances of springtime remind us at the New River Valley Agency on Aging that is time to look ahead and start working on our annual Area Plan for Aging Services. The new plan will take effect in October 2014 and run through September 2015. The Area Plan delineates how resources provided from the Older Americans Act will be allocated. Although the Older Americans Act provides guidelines on services that can be provided, there is broad array of service possibilities. We do not provide all of the possible services due to funding limitations and identified needs.

With a current budget of about \$1.4 million, the NRV Agency on Aging provides aging services with federal, state and local support. The largest programs include Home Delivered Meals, Congregate Meals/Friendship Cafes, Transportation, Information and Assistance, and Homemaker services.

Client waiting lists currently exist for the Homemaker Services. Other services provided include Health Insurance Counseling and Medicare Fraud Prevention, Elder Abuse Prevention, Long Term Care Ombudsman, Care Coordination, Legal Services, Public Information, Long Term Care Coordination, Care Giver Support including Respite Care and a Grandparents Raising Grandchildren Support Group in Pulaski County.

The NRV Agency on Aging's service area includes the counties of Montgomery, Pulaski, Giles, and Floyd and the city of Radford.

We welcome and encourage your comments on these services or other needed services. From March through mid-May we will be soliciting comments from the general public and from those receiving our services. After the state budget is adopted and we receive our funding allocations we will put together a draft Area Plan. The draft Plan should be ready by late May and will be widely distributed in local libraries, government offices, and

other human services offices, in our office and on our website for viewing by the public. A public hearing on the draft Plan will be held at the Agency on Aging in Pulaski on Tuesday, June 17, 2014 at 10:00 a.m.

We are eager to engage others in the process so that we know that we are fairly representing as much as possible, the needs of aging adults in the New River Valley.


